## About IIM Rohtak

Indian Institute of Management Rohtak, established in 2009 by the Ministry of Education, Government of India, is an institute of national importance. Indian Institute of Management Rohtak is a benchmark for top management education in India with a vision to become a global leader in due course. The institute has an enlightened and progressive leadership, acclaimed faculty members, extensive infrastructure, and robust teaching pedagogy in place.

Located within the National Capital Region (NCR) of India, the permanent campus of IIM Rohtak is 90 minutes from Delhi international airport.

The state-of-the-art campus spread over an area of 200 acres, is strategically located on National Highway - 10, and is well connected to Delhi. The extension campus of IIM Rohtak will start at Gurugram.

IIM Rohtak has been ranked 8th in the country on educational ranking. Institute offers a dynamic environment for high-quality research in all functional areas of management that will benefit various segments of the business and society.



## About IPL Programme

IIM Rohtak introduces Five-Year Integrated Programme in Law (IPL) for students after class XII. The interdisciplinary program aims at providing an in-depth knowledge of business management with intricate details of law and governance. On successful completion of the academic rigor of 5 years, the participant will be awarded with Integrated Degree of BBA-LLB. There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated programme, at any intermediary stage of the programme.

It will be a non-residential programme eventually housed at IIM Rohtak extension campus (Gurugram).

## Programme Structure & Curriculum

Overall, the programme consists of 15 terms spread over a period of 5 years. A year has three terms, each of 3 months duration. The entire programme consists of courses in Business Management and Legal Education. Students will be undergoing several internships during the course of the programme.

The programme will create an opportunity for the students to pursue legal education of global standards through a curriculum and pedagogy that best reflects the study of international law, comparative law, foreign law and domestic law. Apart from these, students will also undergo courses from the domain of Business Management, International Affairs, Humanities, Public Policy, and Foreign Languages.



## Admission Criteria

Candidates must satisfy the following criteria to apply for this programme.

- General, NC-OBC and EWS Category: Minimum 60% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as on June 30, 2023.
- SC, ST and PWD (DAP) Category: Minimum 55% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as on June 30, 2023.

Note 1: Candidates who are likely to complete standard XII/ HSC or equivalent by the end of June 2023 can also apply, subject to meeting the minimum eligibility criteria after the declaration of results (only in case of XIIth standard) as mentioned above. If selected, such candidates will be offered admission to the programme provisionally. At the time of registration for the programme, such candidates must produce X and XII standard mark sheets (securing minimum marks, i.e. 60% for General, EWS, and NC-OBC or 55% for SC, ST and PWD) along with school leaving certificate/migration certificate, failing which the candidate's admission offer stands cancelled.

Note 2: The percentage of marks obtained by the candidate in X and XII standard would be calculated based on the aggregate marks of the best five subjects that appear on the mark sheet/grade sheet, irrespective of the Board's regulation. In case the candidates are awarded letter grades or grades points instead of marks, the conversion of grades to percentage of marks of best five subjects would be based on the procedure certified by the Board / Competent Authority explaining the method of conversion from where they have obtained the certificate.



# Selection Procedure

## Stage 1: Online Registration

- Interested applicants who fulfil the eligibility mentioned above criteria can register for the IPL admissions 2023-28 batch via the registration link provided on the institute website.
- Applicants for admission to the programme will be shortlisted based on their scores in ANY of the following entrance examinations:

(a) **CLAT Examination (Common Law Admission Test) 2023:** The candidate interested in the IPL admissions at IIM Rohtak may appear for CLAT 2023. Candidates will register on the IIM Rohtak's IPL registration portal by using CLAT Application No. The eligible candidate will pay a non-refundable registration fee of Rs. 3890/- (Three Thousand Eight Hundred Ninety only)

(b) **IPM Aptitude Test (AT) 2023:** The candidate interested for the IPL admissions at IIM Rohtak and did not appear for CLAT 2023, can also apply for IPL programme by appearing for IPM AT 2023. Such candidate will have to select the option of IPL Programme along with IPM Programme during the registration process. These candidates will appear for 4 sections in the IPM AT 2023 (Quantitative Ability, Logical Reasoning, Verbal Ability, and **Legal Reasoning**). The eligible candidate will pay a non-refundable registration fee of Rs. 4175/- (Four Thousand One Hundred and Seventy-Five only)

## Stage II: Shortlisting and Online Personal Interview

- The shortlisted applicants will be called for the Online Personal Interview based on minimum eligibility criteria and CLAT Score 2023/ IPM AT 2023 Score.
- The Call for Online Personal Interviews (PI) announcement will be done in the First Week of June 2023 (Tentative).
- The candidates, during their interviews, will be evaluated based on their academics, general awareness, and communication skills.
- The interviews are proposed to be held in Second Week of June 2023 (Tentative).



### **Stage III: Announcement of Selection List and Offer Acceptance**

- The final Merit List will be generated based on the composite score of the entrance examination, past academics, and personal interview.
- The institute will announce the merit list tentatively by the first week of July 2023. Selected candidates will receive the offer letter for IIM Rohtak IPL Admission 2023 shortly after the declaration of the merit list. The candidates will be required to accept the offer within the stipulated date and will be required to deposit Rs. 1,000,00/- as the Offer Acceptance Amount (OAA) through online payment link.

### **Stage IV: Provisional Admission to IPL03 (2023-28)**

- The candidates accepting the offer of admission to IPL 03 (2023-28) will be given a confirmation letter. The candidate is required to pay Rs.2,000,00/- towards the 1st instalment of First Year Programme Fee. The candidate will also be required to report physically on the Institute campus for registration on the stipulated date.
- If the candidate registers for the programme within the stipulated date, his/her OAA will be adjusted with the First Year Programme Fee. The fees structure for IPL 03 is available on website.
- Further, on the day of reporting to the campus for registration, the admission team will do physical verification of the documents. In case of online registration, the documents will be verified virtually.
- In case a candidate withdraws after paying the Offer Acceptance Amount but before paying the 1st instalment of first year programme fee, the OAA will be refunded after deducting processing charges of Rs. 1,000/-.
- In case a candidate withdraws before the in-campus/ online registration but after paying the 1st instalment of first year programme fee, the first year programme fee will be refunded after deducting processing charges as applicable from time to time.



- Last Date for any withdrawal of provisional admission will be **‘On or before the date of Registration’** (online/ on campus as the case may be). No refund of any fee will be permissible after the date of registration.
- If a candidate fails to pay the 1<sup>st</sup> instalment of First Year Programme Fees by the stipulated date as mentioned in the admission confirmation letter, the seat will be cancelled.
- The academic session will begin in the first week of August 2023.

#### **Note:**

- The admission criteria for IPL 2023-28 may be changed before the declaration of the results.
- The information in this document is applicable only for the admissions cycle IPL 2023. IIM Rohtak reserves the right to change, modify or adopt any new admission process that it deems necessary, at any point.
- Any dispute concerning Admission for the IPL Batch 2023-28 would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Rohtak only.
- You will receive all admission offers in the form of letter duly signed by admission chair of IIM Rohtak sent from [ipladmission@iimrohtak.ac.in](mailto:ipladmission@iimrohtak.ac.in). Any offer received from any other email is completely invalid and is not official. All admissions to IIM Rohtak are provisional till you have completed all formality upon reporting to the institute.
- If at any point of time, it is found that the information provided by the candidate is false, incorrect, or misrepresented, the admission offer will stand cancelled.
- IIM Rohtak reserves the right to change, modify or adopt any new admissions process that it deems necessary, at any point.

#### **Registration for IPL Programme:**

Final shortlisted candidates who have deposited Offer Acceptance Amount and got a confirmation letter for provisional admission, will be required to report in the campus for registration process followed by physical verification of educational document and other testimonials as per checklist.
